

Defense Supply Chain Cyber Resilience Labs

In partnership with California's ETP, El Camino College is offering a 25-hour readiness

workshop designed to help DoD suppliers understand the DFARS 7012 requirements and forthcoming Cybersecurity Model Certification (CMMC) audit requirements. The workshop sessions are led by industry experts who will facilitate group learning. Participants who attend the workshop will be expected to complete assigned learning modules to begin developing a Systems Security Plan (SSP) and progress towards becoming compliant with DoD-mandated NIST cybersecurity controls. The classes will be instructor-led via a Zoom classroom.

In order to retain their existing DoD and aerospace customers and enable sales growth with new customers, M&R needed to update their Quality Management System. CMTC partnered with M&R to implement a multi-step plan to prepare the company for successful certification to AS9100: (RevD) by its 3rd-party registrar, which included creation or modification of documentation; implementation and training on procedures; training on internal auditing; corrective action training; and training on Management Review.

As a result, M&R increased their sales by \$300,000, retained \$400,000 in sales, and added 7 new jobs. M&R is also now well-positioned to compete for additional DoD and aerospace business to help achieve its growth goals.
